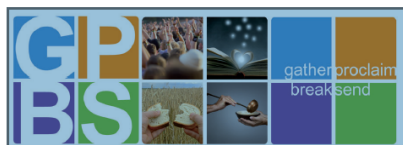

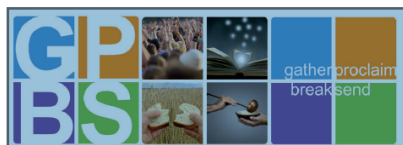

#### **Conditions:**

The tour prices are based on general transport, accommodation and other costs at foreign exchange rates at 1 August 2018. GPBS and Minna Travel & Cruise reserves the right to alter the tour price or modify the tour if any of these factors change, giving any passenger that has booked the right to withdraw with a full refund of monies paid if the price increase is greater than 10% than the original price. #### **Changes:**

#### **Travel Insurance:**

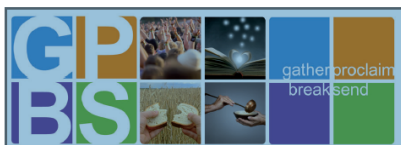
Travel insurance is compulsory to cover the costs of cancellation fees due to illness, death in family, illness while overseas and any accidents etc. See also responsibilities below.
